GRUPA KLEPSYDRA COMPLETES SIXTH ACQUISITION – ZIELEŃ MIEJSKA FROM BIELSKO-BIAŁA NOW IN PORTFOLIO! COMPANY DEBUTS ON NEW GEOGRAPHICAL MARKET

Grupa Klepsydra, the leader in the Polish funeral services market and the first company from this sector listed on the Warsaw Stock Exchange, has signed a notarial deed of purchase for the organized part of the enterprise (OPE) named Zakład Pogrzebowy Zieleń Miejska in Bielsko-Biała. This is the result of winning a tender announced in November this year by Bielskie Przedsiębiorstwo Komunalne sp. z o.o. (formerly Zieleń Miejska sp. z o.o.). The purchase price was PLN 4,823,500. Grupa Klepsydra was represented in the tender by its subsidiary, Centrum Pogrzebowe Zieleń Miejska sp. z o.o.

Grupa Klepsydra has become the owner of one of Bielsko-Biała's oldest, fully equipped and operational funeral homes, which also includes a crematorium. The capital group currently includes 10 funeral homes and 3 crematoria.

The organized part of the funeral enterprise "Zieleń Miejska" in Bielsko-Biała, covered by the signed agreement, includes among others: real estate at Karpacka Street 162 with an office-warehouse building, lease rights to part of the land and chapel premises with cremation facilities, transport vehicles and operational equipment used for funeral services, rights to the "Zieleń Miejska" brand and logo, as well as contracts related to the business activities.

"As announced, we have signed a binding agreement to acquire the organized part of the funeral enterprise Zieleń Miejska in Bielsko-Biała. This is one of the oldest funeral homes in the city, with a strong and well-known brand and an experienced, motivated team of employees who have been connected to the funeral industry for years. We plan to integrate the company into our capital group, streamline internal processes, and introduce customer service standards that have proven successful in other Group companies. Our goal is to further develop this company and strengthen its position in the local market. This also represents a new geographical market for us, thereby enhancing Grupa Klepsydra's position across the country," – said **Marek Cichewicz**, CEO of **Grupa Klepsydra** holding company.

"We are successfully continuing the implementation of our development strategy, which involves consolidating the fragmented funeral market in Poland. We have just finalized our sixth acquisition since our debut on the Warsaw Stock Exchange in June 2023. This means our capital group is now 2.5 times larger than at the time of the stock market debut—we currently manage 10 funeral companies. The next year will certainly bring further acquisitions," added **Marek Cichewicz**.
